



Collegiate Convention Awards

Best Financial Support – recognizes the largest cumulative total of funds donated to the Foundation by a collegiate chapter for the Convention biennium.

1. Award and honor roll recipients are determined by the Foundation based on cumulative funds received during the Convention biennium.
2. Foundation staff determine the award and number of honor roll recipients and reserve the right not to make an award.
3. No award application is required.
4. Fraternity Good Standing is not required to be named an award or honor roll recipient.
5. To provide enhanced recognition, an award and honor roll recipient(s) may be named in different chapter membership size categories or structures.
6. Chapter membership size categories or structures, established by the Fraternity for Convention recognition programs, are used for honoring top-donating chapters for the Convention biennium.

Best New Chapter Support – recognizes the largest cumulative total of funds donated to the Foundation by a new collegiate chapter for the Convention biennium.

1. New chapters are based on the Fraternity's New Chapter Development status. A chapter qualifies if they participated in the Fraternity's New Chapter Development program at any time during the Convention biennium.
2. Award and honor roll recipients are determined by the Foundation based on cumulative funds received during the Convention biennium.
3. The Foundation determines the award and number of honor roll recipients and reserves the right not to award.
4. No award application is required.
5. Fraternity Good Standing is not required to be named as an award or honor roll recipient.

Most Improved Financial Support – recognizes the largest increase in total cumulative biennium contributions to the Foundation by a collegiate chapter from one Convention biennium to the next.

1. Award and honor roll recipients are determined by the Foundation based on dollar differences in cumulative biennium giving from one Convention biennium to the next.
2. Foundation staff determine the award and number of honor roll recipients and reserve the right not to make an award.
3. No award application is required.
4. Fraternity Good Standing is not required to be named an award or honor roll recipient.
5. To provide enhanced recognition, an award and honor roll recipient(s) may be named in different chapter membership size categories or structures.

6. Chapter membership size categories or structures, established by the Fraternity for Convention recognition programs, are used for honoring chapters with the largest increase in giving from one biennium to the next.
7. Should a chapter's membership size change from one biennium to the next, the most current size category shall be the basis for recognition.

Creative Fundraising Award – recognizes creativity in a Foundation fundraiser by a collegiate chapter during the Convention biennium.

1. The purpose of this award is to provide enhanced recognition for creative Foundation fundraisers and gather and share new fundraising ideas.
2. Award and honor roll recipients are determined by the Foundation based on a point system.
3. Foundation staff determine the award and number of honor roll recipients and reserve the right not to make this award. Chapter membership size is not considered in determining this award.
4. **An award application is required.**
5. Multiple award applications may be submitted by a collegiate chapter for different Foundation fundraising events held during the biennium.
6. Fraternity Good Standing is not required to be named as an award or honor roll recipient.

Best Financial Support per Member – recognizes largest cumulative total of funds, per member, donated to the Foundation by a collegiate chapter for the Convention biennium.

1. The purpose of this award is to provide recognition to chapters raising the highest dollars through a Foundation fundraiser, based off a chapter's membership size.
2. Award and top recipients are determined by the Foundation based on cumulative funds received during the Convention biennium, and the chapter roster total number provided by the Fraternity as of April 1, of the most recent fiscal year.
3. Foundation staff determines the award and top recipients and reserves the right not to make this award.
4. No award application is required.
5. Fraternity Good Standing is not required to be named as an award or top recipient.

#AlphaGamGives Fundraising – recognizes involvement and participation, by a collegiate chapter, in the Alpha Gamma Delta Foundation's Day of Giving fundraising campaign, during the most recent fiscal year.

1. Award and honor roll recipients are determined by the Foundation based on overall efforts of '\$1K in a Day,' a 24-hour fundraising campaign created for friendly competition among collegiate chapters that runs in conjunction with *Day of Giving*.
2. Such efforts include but are not limited to total dollars raised, number of donors, number of individual/sister fundraising pages created and marketing efforts.
3. Chapters must use the '\$1K in a Day' fundraising event, created by Foundation staff using the CrowdChange fundraising platform, to be considered.
4. Foundation staff determines the award and honor roll recipients and reserves the right not to make this award.
5. No award application is required.
6. Fraternity Good Standing is not required to be named as an award or honor roll recipient.
